





ON THE FRONT-PAGE THE PAINTING "BIRTH OF THE CONSTITUTION"

The painting "Birth of Constitution" of the internationally recognized painter Rudik Petrosyan is unique both in terms of concept and implementation. Gregory the Illuminator and King Trdat are on the right side of the triptych. They symbolize adoption of Christianity as the state religion in Armenia and systemic-value orientation of the Armenian people. In the center of triptych the portrayal of abstract representation of perception of Ashtishat Assembly dated 365 A.D. is presented which with unique skills portrays: a) people with an unwavering will to self-knowledge and life in accordance with constitutional canons, b) harmony of the symbol of justice with public mood, c) creation of the Constitution by the wise men in the current social environment. These summarize the definition of the notion "constitution" presented in the New Haikazyan Dictionary of the Armenian Language published in 1837 in Venice as "Determination of borders and the Divine Providence". On the left side of triptych is portrayed the Armenian historian Movses Khorenatsi, who assessed the canonical Constitution adopted by the Ashtishat Assembly as "established mercy through canonical constitution" which is inscribed on the parchment hold by the angels.

of "The Constitutional Culture"**
International Public Analytic Center

Prevention of social cataclysms, overcoming of the deficit of constitutionalism, the establishment of the rule of law, guaranteeing sustainability for the development of public life are the most significant challenges of the new millennium.

They can be achieved through constitutionalization of the social relations, by guaranteeing the supremacy of Constitution in reality and ensuring a necessary level of the constitutional culture.

The constitutional culture is a culture of civilized cohabitation, which is more typical for the states and nations which have achieved a certain level of the democratic development. Its elements form and develop throughout history. However, it reaches systemic integrity at a certain level of development, when along with the Constitution the necessary and sufficient level of constitutionalism is guaranteed while implementing the fundamental constitutional values and principles when the rule of law becomes dominant.

Nevertheless, in the contemporary world, the deficit of constitutionalism reaches a dangerous scale; the corruption reaches dangerous dimensions, the displacement of millions of people by force, social polarization and coalescence of the political, economic and administrative potential.

The experts face a serious problem to propose more sufficient solutions for the establishment of the necessary and sufficient level of constitutional culture in the public life and guaranteeing constitutionalism.

The latter requires mobilization of resources and continuous, systemic and consistent work.

Establishment of the international public analytic center "The Constitutional Culture" pursues this aim.

The initiative group targets to:

- a) develop an annual action plan regarding the presented fundamental issues which will include thematic discussions with the involvement of international experts and make the results accessible to the international community;
- b) pay particular attention to the development of the principal elements of transitology and its implementation in this sphere;
- c) based on international fundamental documents, conclusions of the Venice Commission, the case law of the European Court of Human Rights, suggest functional and institutional solutions for the introduction of a functional system for conducting constitutional diagnostics and constitutional monitoring;
- d) elaborate and publish resolutions regarding the real state of constitutional culture in some countries;
- e) support institutes of civil society for undertaking efficient measures in this sphere;
- f) contribute to the achievement of consistent knowledge regarding constitutional culture among youth;
- g) organize youth festivals, Olympiads and scientific-practical discussions regarding the fundamental issues of the constitutional culture;
- h) ensure that the subject of the constitutional culture be widely taught in the specialized educational institutions, for that purpose prepare necessary programs and educational guidebooks;
- i) publish "Constitutional Culture" multilingual journal.

THE MAIN GOALS AND FUNCTIONS OF THE CENTER

The aim of the Center is to develop and implement programs which will contribute establishing the necessary and sufficient level of constitutional culture in public life.

The goals of the Center are:

1. with the involvement of international and national experts, to elaborate and enforce the annual action plan regarding the study on the fundamental issues of the constitutional culture and urgent issues of that sphere,
2. with the involvement of international and national experts, to elaborate and implement the principal elements of transitology in the sphere of constitutional culture,
3. to elaborate functional and institutional solutions for the introduction of a functional system for conducting diagnostics of constitutionalism and constitutional monitoring, based on international basic documents, conclusions of the Venice Commission and case law of the European Court of Human Rights, with the involvement of international and national experts,

The main functions of the Center are:

1. With the involvement of international and national experts, to elaborate and publish the resolutions regarding the real state of constitutional culture in a number of countries,
2. to support the institutions of civil society for initiating efficient measures in the field of constitutional culture,
3. to contribute to the achievement of consistent knowledge regarding constitutional culture among the youth,
4. with the involvement of international and national experts, to organize and conduct youth festivals, Olympiads and scientific-practical discussions regarding the fundamental issues of the constitutional culture,
5. to undertake efficient measures for the introduction of the subject "Constitutional Culture" in the programs of the specialized educational institutions and

preparation of necessary programs and educational manuals,

6. to publish of "Constitutional Culture" multilingual journal,
7. to publish significant works in the field of constitutional culture,
8. to contribute the implementation of significant programs in the field of the constitutional culture,
9. to contribute the organization, training and requalification of the specialists in the field of constitutional culture,
10. to support programs aimed at ensuring the development of young scientists in the field of constitutional culture.

ESTABLISHMENT OF THE CENTER

On October 21, 2016 a reception on behalf of H.E. Mr. Serzh Sargsyan, President of the Republic of Armenia was organized at the Receptions House of the Government of the Republic of Armenia in honor of the Participants of Yerevan International Conference, organized by the Constitutional Court of the Republic of Armenia, European Commission for Democracy through Law of the Council of Europe (Venice Commission), Conference of the Constitutional Control Organs of the Countries of New Democracy, Center of the Constitutional Law of the Republic of Armenia (with the support of the Armenian Office of the German Corporation for International Cooperation (GIZ).



During the reception, the Solemn Ceremony of Establishment of the Foundation "**International Public Analytical Center "Constitutional Culture"**" took place.

Mr. G. Harutyunyan, President of the Constitutional Court of the Republic of

Armenia mentioned the necessity of establishing the Center and its main functions.

The idea of establishing the Center was widely supported and received an offer of cooperation from a number of international analytical centers and individual experts, and it will carry out its functions with a wide involvement of the latter. In particular:

- conducting analytical work on issues of constitutional culture, as well as organization of international conferences, scientific and practical discussions;
- functional and institutional arrangements in different countries on the implementation of effective systems of diagnostics of constitutionalism and constitutional monitoring;
- preparation and publication of opinions about the real situation in connection with the constitutional culture in individual countries;
- active cooperation in this field with a number of international and regional organizations;
- support for civil society institutions on the issue of establishment and acceleration of constitutional culture, conduct of youth festivals and Olympiads;
- publishing the "Constitutional Culture" multilingual journal.



SPEECH OF DR. GAGIK HARUTYUNYAN ON THE OCCASION OF ESTABLISHMENT OF THE CENTER

*Your Excellency Honorable
Mr. President of the Republic of Armenia,
Distinguished Guests,
Colleagues,*

The international experience of the constitutional justice, as well as the developed discussions within the framework of ongoing pan-European conference convened in Yerevan indicate the level of urgency that the matters of establishment of constitutionalism and guaranteeing the rule of law have obtained throughout the modern world. It is undeniable, that in each state the main guarantee for achieving sustainable development is the establishment of constitutional democracy. The latter, in its turn, requires consistent constitutionalization of public affairs, as well as necessary and sufficient level of constitutional culture. Taking into consideration the urgency of the respective matter and the necessity to consolidate professional potential for withstanding the existing challenges, we have launched the process of founding the "Constitutional Culture" International Analytical Center. Among the main functions of the Center are, particularly, with the involvement of international experts: - to conduct scientific-analytical activities, organize international conferences, scientific-practical discussions regarding the fundamental issues of constitutional culture; - to elaborate functional and institutional solutions for the introduction of a functional system for conducting diagnostics of constitutionalism and constitutional monitoring; - to draft and publish resolutions regarding the real state of constitutional culture in a number of countries; - to actively co-operate with various international and regional organizations in the mentioned sphere; - to support the institutions of civil society with the issues of rooting and developing constitutional culture, to organize and conduct youth festivals, Olympiads; - to publish "Constitutional Culture" multilingual journal, etc. It is planned to convene an international conference "Present Challenges of Deformation of the Spiritual and Legal Human Behavior and the Imperatives of their Overcoming" in 2017. Taking into account that 2018 will be announced as a cultural year in Europe, it is planned to convene the 2018 International Conference on the topic "The Challenges of the Culture of Co-Existence in the Modern World and the Imperatives of their Counteraction". Within the frames of the latter the axiological and constitutional-legal prerequisites of the civilized co-existence and tolerance will be especially touched upon. I am sure that many of you will have an opportunity to be an active participant of the initiatives of the Center, to introduce your experience and knowledge to the effective realization of the efforts for the development of constitutional culture in the modern world. Once again expressing gratitude to all our colleagues joined to this initiative, let's wish a successful start and productive activities to the newly established Center. Thanks for your attention!

A BOOK WHICH DESERVED PAN-EUROPEAN ATTENTION



On January 26, 2017 in the premises of the Council of Europe, the event dedicated to the issues of constitutional culture organized together with the International Analytical Center "Constitutional Culture", the German Corporation for International Cooperation (GIZ) and permanent representation of the Republic of Armenia was held.

H.E. Mr. T. Jagland, Secretary General of the Council of Europe, Mr. G. Buquicchio, President of the Venice Commission of the Council of Europe, Mr. A. Sajó, Vice-President of the European Court of Human Rights, judges of ECHR, members of diplomatic corps accredited to the Council of Europe, members of Armenian and foreign delegations and other officials were present at the event.

held an opening speech. He informed that in the framework of the 16-th anniversary of membership of Armenia to the Council of Europe, this event was dedicated to the foundation of International Analytical Center "Constitutional Culture" and publication of "**Constitutional Culture: Lessons of History and Modern Challenges**" monograph (in English), publication of the Constitution of the Republic of Armenia in four languages and almanac of the materials of Pan-European Conference held on October 20-23, 2016 in Yerevan.

In his address H.E. Mr. T. Jagland, Secretary General of the Council of Europe emphasized the active participation of the Republic of Armenia in all initiatives of the Council of Europe. "We are devoted to the Armenia which is stable, prosperous and looking to the future," said Mr. Jagland, "Our relations are bilateral, and I appreciate the strong commitment of Armenia to dialogue and cooperation ... We appreciate the honest and engaged way by which Armenia is approaching various proposals."

The English monograph "**Constitutional Culture: Lessons of History and Modern Challenges**" was presented by Ms. Alvina Gyulumyan, Member of the Constitutional Court of the Republic of Armenia who emphasized the practical and scientific importance of the book in the establishment of constitutional culture in the member states of Council of Europe.

Mr. Vardan Poghosyan, Head of the Legal Project of the German Corporation for International Cooperation (GIZ), substitute member of the Venice Commission presented the recently published the 2015 edition of the amended Constitution in four languages.



NEW BOOK OF ENCYCLOPEDIC VALUE

At the initiative of Professor G. Harutyunyan, Chairman of the Board of Trustees of the International Analytical Center "Constitutional Culture", and with the blessing of Catholicos of All Armenians Karekin II, the author's team is preparing to publish the two-volume book "**Axiological Origins of Constitutional Culture in the Millennial Chronicle of the First Nation to Adopt Christianity as a State Religion**".

Secular and ecclesiastical specialists are involved in the preparation of the publication, and their regular working meeting was held on June 21, 2017.

The work of the author's group and the editorial team is coordinated by Professor G. Harutyunyan. The editorial staff includes Arthur Vagharsyan, Head of the Chair of Theory and History of State and Law of the Yerevan State University, Artak Movsisyan, Acting Head of the Chair of the History of Armenia, and Supreme Archimandrite Shahe Ananyan, representative of the Supreme Patriarch.

Themes of the sections of the two-volume book will be presented by Artak Movsisyan, Azat Bozoyan, Aleksan Hakobyan, Ashot Voskanyan, Arman Yegiazaryan, Gagik Harutyunyan, Gegham Badalyan, Grigor Tananyan, Hayrapet Margaryan, and Narine Mirzoyan.

This voluminous work will include various pages of the history of development of social relations, beginning with the ancient Armenian kingdoms (from Aratta to Urartu) to our times. In this work, the authors will disclose the historical necessity of convening the Secular Assemblies and then the National Ecclesiastical Assemblies, the peculiarities of their organization, as well as the scientific and legal role and significance of the adopted canonical constitutions. In the framework of a comprehensive comparative analysis, the National Ecclesiastical Assemblies of Vagharsapat, Ashtishat, Shahapivan, Dvin, Karin, Aghvank, Partav, Manazkert, Shirakan, Ani, Hark, Lori, Dzagavan, Shugri, Homkla, Tarson, Sis, and Adana, as well as the "Armenian Book of Canons", the scientific and legal heritage of Sahak Partev, David Alavkavordi, Nerses the

Gracious, Mkhitar Gosh, and Smbat Sparapet, as well as the Lawcode of Polish Armenians, the Lawcode of Astrakhan Armenians, "The Snare of Glory" by Shahamirians, and the National Constitution of the West Armenians will be presented.

The two-volume book will also be presented in English, and the broad international community will have an opportunity to get familiar with the formation and development of the Armenian legal and constitutional culture.

The book will be published in spring of 2018.






